This is a letter of recommendation for interpreter [REDACTED]. During the period of 31st August 2003 – 20th September 2003 [REDACTED] was employed under my command for a large operation removing illegal weapons from circulation. [REDACTED] was a vital asset to our operation as a lot of information concerning weapons came from local people. [REDACTED] played a vital role in helping us build a rapport with these people. 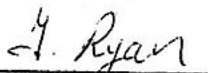
